Emily Clough is a Partner in Clark Wilson LLP's Estates & Trusts group. Emily is the key contact for the Clark Wilson Elder Law practice. In 2020, Emily received the designation of TEP, as an experienced practitioner from the Society of Trust and Estate Practitioners. The TEP designation is internationally recognized and demonstrates expertise in the field of trusts and estates.

Emily advocates for clients as they deal with any type of incapacity or estate matter. She assists clients in preparing estate and personal plans, in administering the estates of a deceased, and in litigating any matter regarding estates and trusts.

Emily prepares both simple and complex estate planning documents for clients, including wills, powers of attorney, representation agreements, advance directives, trusts, alter ego trusts, joint partner trusts, and disability trusts.

Emily advocates on behalf of older adults and adults with cognitive impairment. She frequently acts as counsel in matters regarding adult guardianship, the *Patients Property Act*, the *Adult Guardianship Act*, and the *Mental Health Act*. She assists clients in navigating issues of elder abuse, including dealing with the Public Guardian and Trustee, the health authorities, the police, and the courts.

Emily assists executors and administrators in addressing all matters that may arise regarding the administration of an estate. She advises and represents clients in applying for probate, passing of accounts, seeking remuneration, and any other litigation matters that may arise.

In her litigation work, Emily has been lead counsel on cases at all levels of Court in British Columbia regarding

estates, variations of wills, trustee duties, power of attorney duties and removal, elder abuse, and other related matters. She acted as counsel in cases that have set new law and precedents in British Columbia, including on wills variation and the incapacity to marry. Her cases have received national coverage by the Globe & Mail and the CBC.

Emily is the Chair of the Pro Bono Committee at Clark Wilson, coordinating the pro bono efforts of 90+ lawyers. She is a member of the Ethics Committee at Clark Wilson, providing lawyers at her firm with guidance on their obligations under the British Columbia Law Society Code of Professional Conduct.

Emily is a regular contributor and volunteer regarding estates, trusts and incapacity matters. She provides educational seminars to other lawyers for Continuing Legal Education British Columbia (CLEBC), the Trial Lawyers Association of British Columbia (TLABC), the Canadian Association of Gift Planners (CAGP), and other organizations. She volunteers to prepare estate planning documents for older adults on a pro bono basis. She regularly provides educational seminars to the staff and clients of the Alzheimer Society of British Columbia, including training their staff regarding estate planning matters.

Emily was nominated for the 2019 YWCA Women of Distinction Awards, recognizing that she is a leading elder law lawyer, has been counsel in landmark cases, and advocates for the rights and dignity of vulnerable adults. Emily has provided expert evidence in Australia regarding the British Columbia laws on estates.

In 2018, Emily was appointed by the Attorney General of British Columbia to the Board of Directors of the British Columbia Law Institute (BCLI). The BCLI carries out scholarly research, writing and analysis for law reform as the independent law reform agency in British Columbia. The BCLI is the parent body for the Canadian Centre for Elder Law, a national non-profit body dedicated to exploring the particular legal issues that affect older Canadians. In 2020, the Attorney General of British Columbia re-appointed Emily to the BCLI for a further 4-year term. Emily currently serves on the Executive Committee for the BCLI, and is a committee member on the Inclusive Investing project.

In 2020, Emily was appointed as the first President of Health Justice, a not-for-profit Society in British Columbia. Health Justice uses research, education, and advocacy to improve the laws and policies that govern coercive health care in BC. The current priority of Health Justice is to better support human rights in involuntary mental health and substance use care by reforming the British Columbia Mental Health

Emily strives towards constant education. She received the award as the top student in the Honours Program in her senior undergraduate year at Gonzaga University. At law school at the University of Victoria, she earned the prize in legal research and writing, published an article in a scholarly journal, and was an editor-in-chief of the scholarly legal review journal of the University of Victoria law school. She regularly attends conferences and educational seminars in British Columbia and globally, attending the Society of Trust and Estate Practitioners Global conferences in Amsterdam (2016) and in Vancouver (2018).

Prior to joining Clark Wilson, Emily was a partner at a regional downtown Vancouver law firm. She clerked at the British Columbia Supreme Court after completing law school at the University of Victoria.
