On the recommendation of the undersigned, the ~~Lieutenant Governor~~ <sup>Administrator</sup> by and with the advice and consent of the Executive Council, orders that

- 1 (a) The designation of College of New Caledonia and the area of the Province that is the college region made by Order in Council 2960/78 is rescinded, and
  - (b) College of New Caledonia is designated and the area of the Province that is the college region is the combined areas of the following School Districts established under the *School Act*: No. 28 (Quesnel), No. 57 (Prince George) and No. 91 (Nechako Lakes).
- 2 (a) The designation of East Kootenay Community College, renamed College of the Rockies by Order in Council 1329/95, and the area of the Province that is the college region, made by Order in Council 2962/78 as amended by Order in Council 3059/79, is rescinded, and
  - (b) College of the Rockies is designated and the area of the Province that is the college region is the combined areas of the following School Districts established under the *School Act*: No. 5 (Southeast Kootenay), No. 6 (Rocky Mountain) and the portion of School District No. 8 (Kootenay Lake), lying south of an east-west line that intersects the mouth of Sanca Creek where it enters Kootenay Lake, that was within the boundaries of the former School District No. 86 (Creston-Kaslo) and that was established by Order in Council 3059/79 for East Kootenay Community College.
- 3 (a) The designation of Northwest Community College and the area of the Province that is the college region made by Order in Council 2967/78 is rescinded, and
  - (b) Northwest Community College is designated and the area of the Province that is the college region is the combined areas of the following School Districts established under the *School Act*: No. 50 (Haida Gwaii/Queen Charlotte), No. 52 (Prince Rupert), No. 54 (Bulkley Valley), No. 82 (Coast Mountains), and No. 92 (Nisga'a).
- 4 (a) The designation of Selkirk College and the area of the Province that is the college region made by Order in Council 2969/78 as amended by Order in Council 3060/79 is rescinded, and
  - (b) Selkirk College is designated and the area of the Province that is the college region is the combined areas of the following School Districts established under the *School Act*: No. 20 (Kootenay-Columbia), No. 10 (Arrow Lakes), No. 51 (Boundary) and No. 8 (Kootenay Lake), excluding the portion lying south of an east-west line that intersects the mouth of Sanca Creek where it enters Kootenay Lake, that was within the boundaries of the former School District 86 (Creston-Kaslo) and that was established by Order in Council 3059/79 for East Kootenay Community College.
