## **Additional Work Highlights**

---

### **Proof of Deceased's Inter Vivos Gift of Forgiveness of Mortgage**

- > Houghton-Jukes v. Gough, 2018 ONSC 1525 – Lead counsel in a dispute over whether a mortgage had been forgiven. The only evidence to corroborate the clients' disputed evidence on the deceased's intentions was an ambiguous handwritten notation. Client successfully met onus of establishing elements of inter vivos gift.

### **Defense in Disputed Property Ownership Claim**

- > Robinson v. Kuypers, 2020 BCSC 770 - Co-counsel for defendants in successfully arguing that the plaintiff's ownership claim over property was barred by the limitation period.

### **Successful Representation of Executor in Interpretation of Will**
